Suppliers can update their Certification Body and/or Food Sector Categories during the last two steps of the annual registration process.


The supplier will be presented with the option below right after choosing their payment option

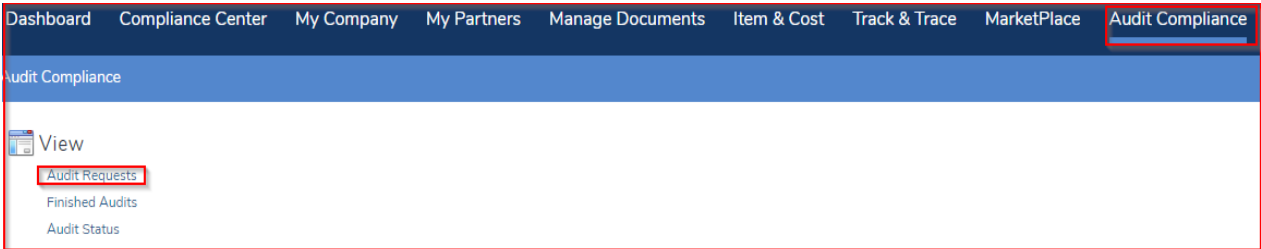

The supplier will also have the ability to update the Certification Body and Food Sector Categories after the registration has been completed and the audit request is in pending.

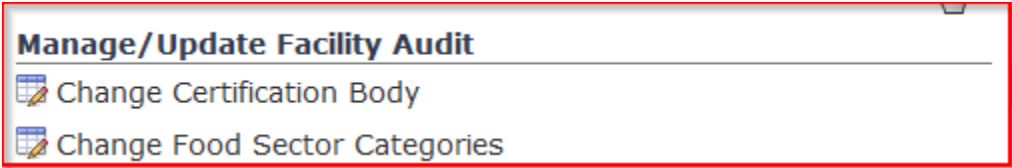
The client should log into ReposiTrak and click on the “Audit Compliance” tab. Then, they must select “Audit Requests”
